#### Detailed Rationale

Infomerics has continued the ratings under 'Rating Watch with Developing Implications (RWDI)' for the bank loan facilities of GOCL Corporation Limited (GOCL).

The ratings have remained under RWDI on account of proposed acquisition of thermal power operations of Hinduja National Power Corporation Limited which is in progress. IVR will continue to monitor the developments in this regard and will resolve the watch once the transaction of acquisition will be completed.

Further ratings have also taken into consideration the conclusion of disinvestment transaction of its wholly owned subsidiary, IDL Explosives Limited (IEL), to Apollo Defence Industries Private Limited for a sale consideration of Rs.107.00 crore

The rating reaffirmation takes into consideration long track record of operations, experienced management coupled with demonstrated support from Hinduja Group. The ratings further derive comfort from moderate capital structure and Memorandum of Understanding (MOU) signed for land monetization amounting to Rs. 3418.00 crore for which Rs. 1750.00 crore has been received till June 30, 2025. However, these rating strengths are partially offset by low profitability, weak debt coverage indicators along with high exposure to other entities coupled with vulnerability of profitability to fluctuations in raw material price.

Infomerics Ratings has principally relied on the consolidated audited financial results of GOCL, IEL and HGHL Holdings Limited up to 31 March 2025 (refers to period April 1st, 2024, to March 31st, 2025) and H2FY26 (refers to period April 1<sup>st</sup>, 2025 to September 30, 2025), and projected financials for FY2026 (refers to period April 1st, 2025, to 2 March 31st, 2026) - FY2027 (refers to period April 1st, 2026, to March 31st, 2027), and publicly available information/ clarifications provided by the company's management.

### **Key Rating Sensitivities:**

#### **Upward Factors**

- Substantial & sustained improvement in the revenue & EBITDA margin while improving the debt protection metrics.

#### **Downward Factors**

- Any further decline in revenue and/or EBITDA margin leading to a decline in debt protection metrics.
- Sizeable increase in direct and indirect exposure to group companies, large acquisitions, or capex.

### **List of Key Rating Drivers with Detailed Description**

#### **Key Rating Strengths**

- **Long track record of operations**

GOCL was incorporated in 1961 for manufacturing industrial explosives, reflecting a track record of more than six decades. In the past, the company had forayed into various segments like lubricants, mining, real estate, wind energy, food chemicals,

pharmaceuticals, etc. through various joint ventures/ subsidiaries. Currently, it has its presence mainly in energetic with realty segments constituting a small proportion of revenue at present.

- **Strong promoter group and experienced management**

The company is a part of the Hinduja Group which came into existence in 1918. It is one of the largest diversified groups having presence in around 30 countries in sectors encompassing automotive, oil &, banking & finance, power, information technology & business process outsourcing, media and healthcare. The company has experienced top management and are well assisted by a team of experienced management professionals whose experience in running various businesses is a key strength for GOCL.

- **Demonstrated support from Hinduja Group**

The operating businesses of the Company mainly comprise of energetic business and realty business. The company has also ventured into the realty segment, wherein it is in the process developing a special economic zone (SEZ) at Bengaluru. The Board is also looking at the opportunities for investments that will be value enhancing for the Company in the international market.

- **Moderate capital structure**

The capital structure of the group stood comfortable marked by the overall gearing ratio at 0.71x as on March 31, 2025, improved from 0.84x as on March 31, 2024, on account of accretion of profits to general reserve along with schedule repayment of bank borrowings along with lower utilization of working capital bank borrowings as on balance-sheet date. However, adjusted tangible net worth remained negative due to significant exposure to group companies and subsidiary.

### **Key Rating Weaknesses**

- **Continuous decline in revenue**

In FY25, the TOI of the company on consolidated level has declined by 8.90% and stood at Rs. 571.09 crore in FY25 compared to Rs. 626.92 in FY24 primarily on account of decline in turnover in IEL owing to fall in realisations. The company reported a 22.88% decline in consolidated operating income, which stood at Rs. 5.61 crore in H1 FY26 compared to Rs. 7.28 crore in H1 FY25. This decrease reflects a strategic

shift in product mix, exist from explosive segment of the group and the impact of the IEL divestment which has now been classified under discontinued operations. Moving forward, the company is actively pursuing new growth opportunities and is in the process of generating revenue from its EMS segment.

- **Weak debt coverage indicators**

The debt protection metrics of the group marked by the interest coverage ratio stood negative at 0.09 times in FY25 compared to negative at 0.04s in FY24. The DSCR of the group improved and stood at 1.72x in FY25 improved from 0.30x in FY24 on account of improved GCA. The total debt to EBITDA stood negative at 110.46 times in FY25 compared to negative at 195.25 in FY24 on account of decline in debt and operational losses registered by the company.

- **High exposure to group/related entities:**

The company's exposure to group/related entities at a consolidated level stood high at Rs. 2482.45 crore as on March 31, 2025, compared to Rs. 2,130.03 crore as on March 31, 2024. It mainly includes loans extended to 57 Whitehall Investments SARL Luxemburg by its subsidiary, HGHL Holdings Ltd., which also holds 10% stake in this company, which in-turn has invested in the downstream joint venture project which is engaged in the development of a residential and hospitality project in the UK.

- **Vulnerability to profitability to fluctuations in raw material price**

The basic raw materials required by the company are coating materials, chemicals, metals, etc. the prices of which are volatile in nature. Hence, the profitability of GOCL is exposed to variations in raw material prices. Also, globally the tensions over trade issues, Russia Ukraine war and Middle East issues are hitting up crude oil prices to a higher level. This is expected to pose problems in the Indian economy unless some de-escalation takes place.

For arriving at the ratings, Infomerics has consolidated view of GOCL and its subsidiary i.e. HGHL Holdings Limited (100%) and IEL (100%) [ now disinvested on November 15, 2025], based on common promoters/ management, cash flow fungibility and strong financial linkages between the entities. Infomerics has analysed the consolidated financial statement to arrive at the ratings.

### **Liquidity – Adequate**

The liquidity position of the company is adequate, marked by expected sufficient cash accruals as against its repayment obligations. The Company's average fund based working capital limit utilization stood moderate at below 45% during last 12 months ending October 2025, indicating adequate buffer in its working capital limits. The current ratio of the group stood at 4.46x as on March 31, 2025. Further, the company expects sufficient cushion in cash accruals against its debt repayments. The Working Capital Cycle of the company stood at 26 days in FY25 days against 59 days in FY24.

### **About the Company**

GOCL, formerly Gulf Oil Corporation Limited, was incorporated in 1961 as Indian Detonators Ltd. (IDL), in Hyderabad. The company is a part of the "Hinduja Group" which is one of the largest diversified groups in the country spanning various sectors of the economy. The Company's equity shares are listed on the Bombay Stock Exchange (BSE) since 1963 and on

the National Stock Exchange (NSE) since 2007. GOCL is a multi-division, multi-location Company, a key player in businesses in energetics and realty. It had 2 wholly owned subsidiaries – IDL Explosives Limited and HGHL Holdings Limited in UK, and on November 15, 2025, it has disinvested IDL Explosives Limited to Apollo Defence Industries Private Limited.
