Detailed Rationale

The reaffirmation of the ratings assigned to the Basel III-compliant Tier II bonds of Shivalik Small Finance Bank Limited (SSFB) consider Banks improving business scale supported by periodic equity infusions, improvement in portfolio composition with higher proportion of secured loans and reduction in the proportion of stressed microfinance loan book.

These strengths are, however, partially offset by deterioration in already thin profitability, as reflected in a low return on total assets (ROTA), average asset quality metrics due to stress in microfinance portfolio, and geographical concentration of operations.

The revision of the outlook to *Stable* from *Positive* reflects SSFB's continued dependence on periodic equity infusions to maintain its capital adequacy while growing its loan book. This reliance stems from limited internal capital generation, as operating and credit costs remain elevated due to bank's ongoing expansion of its franchise. The outlook also factors in a sustained high credit–deposit (CD) ratio, pressure on funding costs arising from competitive deposit mobilisation, and further deterioration in proportion of CASA deposits.

Note on Basel-III Compliant Tier-II Instruments: Basel III–compliant Tier II instruments carry a point of non-viability (PONV) clause, the invocation of which could result in a write-down of principal or conversion into equity, leading to a loss for investors. As per the Basel III framework, the determination of the PONV trigger rests with the Reserve Bank of India (RBI). While Infomerics considers, the probability of such a trigger being invoked being low in the Indian banking context, given the strong regulatory and supervisory framework, the presence of the PONV clause introduces additional risk for investors. This risk has been adequately factored into the rating assigned to the instrument.

Key Rating Sensitivities:

Upward Factors

- Maintaining comfortable capital buffers and improving the liability profile while expanding its branch network.
- Improving earnings and asset quality leading to strong, stable core profitability.

Downward Factors

- Lower equity infusion, resulting in restricted AUM growth or reduced capital adequacy.
- Deterioration in asset quality or lower provision coverage ratio.

Key Rating Strengths

Healthy Growth in Business Volumes with Gradual Improvement in Risk Profile-

SSFB has reported steady growth in scale, with AUM increasing to Rs.3,659 crore as on December 31, 2025 (March 31, 2025: Rs.2,970 crore; March 31, 2024: Rs.2,120 crore), driven primarily by housing loans, followed by vehicle, and gold loans. In response to stress observed in the microfinance (MFI) sector, the Bank has undertaken conscious portfolio rebalancing by reducing MFI exposure to 8.5% of total advances as on December 31, 2025 from 18.27% as on March 31, 2024. Further, SSFB's MFI disbursements have been covered under the Credit Guarantee Fund for Micro Units (CGFMU) since July 2024, providing partial credit risk mitigation.

Aided by traction in digital deposits, the Bank's deposits increased to Rs.3,800 crore as on December 31, 2025 (March 31, 2025: Rs.3,161 crore; March 31, 2024: Rs.2,409 crore), . The Bank has plans of raising total business of around Rs.8,500 crore in FY26 – I am not sure about this, please go ahead if you deem it to be correct.

Adequate Capitalisation, though High Reliance on Equity Infusions-

SSFB's capital position remains adequate, supported by periodic equity infusions. The Bank raised Rs.96 crore in FY25 and Rs.102 crore in 9MFY26 from SMBC Asia Rising Fund and has plans of raising an additional Rs.35 crore in Q4FY26. Total capital adequacy, as reflected by CRAR of 20.80% as on December 31, 2025 (20.95% as on March 31, 2025; 23.19% as on March 31, 2024), remains comfortable. However, given modest internal accruals, medium-term growth plans while maintaining the current capital adequacy levels remain contingent on continued equity support.

Moderate Liability Profile with Pressure on Cost of Funds-

While the bank's liability profile is comparable with peer SFBs, the proportion of CASA deposits declined further during 9M FY26 to 20.35% as on 31st December 2025 (22.42% as on 31st March 2025 and 27.98% as on March 31, 2024).

Amid heightened competition for deposits, SSFB increased deposit rates, resulting in a rise in the cost of deposits to 7.16%% during December 31, 2025, from 6.91% in March 31, 2025 (March 31, 2024:6.24%). The ability to improve CASA proportion and stabilise funding costs remains a key monitorable.

Experienced Management Team-

The Board comprises ten directors, including six independent directors, with experience across banking, finance, technology, and governance. The Bank is led by Mr. Anshul Swami, Managing Director & CEO, who brings nearly two decades of banking experience, supported by an experienced senior management team.

Key Rating Weaknesses

Weak Profitability and High Operating Cost Structure-

The Bank's profitability and retained earnings have remained weak over the past 4 years, constraining its internal capital generation, and leading to heightened reliance on periodic equity infusion to fuel its growth ambition while maintaining capital adequacy ratio above 20%. SSFB Pre Provisioning Operating Profit (PPOP) stood at Rs.31 crore December 31 2025 (March 31 2025: Rs.20 crore). Interest income accounted for around 77% of total income in H1FY26, providing stability to earnings; however, treasury income including interest on investments (7.7%) exposes the Bank to market-related volatility. SSFB's net interest margin declined to 4.80% in 9MFY26 (FY25: 5.46%; FY24: 5.95%), primarily due to a reduced proportion of higher-yielding MFI loans and elevated funding and operating costs. The Bank's cost-to-income ratio remained high at over 90% in FY24 and FY25, though it improved to 85.6% in 9MFY26. Sustained improvement in operating efficiency remains critical during the Bank's rapid growth phase.

Deterioration in Asset Quality with Modest Provisioning Buffers-

The weakening trend in asset quality continued during 9MFY26 with GNPA/NNPA increasing to 2.83%/2.01% (FY25: 2.70%/1.51% & FY24: 2.00%/0.80%). The deterioration in asset quality was mainly because of stress in SSFB's MFI portfolio. With the reduction in exposure to MFI loans and increase in proportion of secured loans in the Banks total portfolio, Infomerics expects SSFB's asset quality to improve during FY27. SSFB's Provision coverage (excluding technical write-offs) further declined to 50.80% as on December 31, 2025 (31 March 2025:52.42%, 31 March 2024 :58.71%), limiting buffers against potential slippages.

Geographical Concentration of Loan Book-

Despite gradual diversification, geographical concentration remains a credit constraint. Uttar Pradesh and Madhya Pradesh together accounted for approximately 44% of total advances as on 9MFY26 (down from ~82% at inception). While the Bank has expanded into seven additional states and operates through 215 branches across 105 districts, further geographical diversification is required to meaningfully reduce concentration risk.

Liquidity – Adequate

The bank's liquidity profile remains adequate. The Liquidity Coverage Ratio (LCR) stood at a healthy 171.42% as on December 31, 2025. Moreover, the structural liquidity statement on the same date did not exhibit any cumulative negative mismatches across various maturity buckets. Additionally, the availability of undrawn refinance lines of Rs. 500 crore from SIDBI

and NABARD provides further liquidity comfort. SSFB's net stable funding ratio (NSFR) remain comfortable at 118.92% as on December 31, 2025.

About the Bank

SSFB is the first Small Finance Bank (SFB) in India to have transitioned from an Urban Co-operative Bank. The Bank has over 27 years of experience in offering retail banking products and services. It received in-principal approval from the Reserve Bank of India to set up an SFB on January 6, 2020, followed by the grant of a banking licence on January 1, 2021. SSFB commenced its operations as an SFB on April 26, 2021, and was accorded Scheduled Bank status on July 7, 2021. As on December 31, 2025, the promoter group held 38% of the Bank's equity, while institutional investors accounted for around 21% of the total shareholding.
